In order to apply for an exchange of apartments, you must have had your tenancy agreement for at least one (1) year*, the same goes for the one you wish to change apartment with. If the exchange applies to an apartment owned by another housing corporation, the application must be approved by all the housing corporations involved. The right to exchange is only covered between rented apartments and is not allowed for Youth accommodation. New customer within Kalmarhem must fulfill Kalmarhem's requirements, therefore a credit report is made in connection with the application in accordance with Kalmarhem's rental rules. From the time Kalmarhem receives a complete application, the processing time is about three (3) weeks.

Before the exchange takes place an inspection must take place and be approved, where you as a moving customer are expected to attend. If you fail to attend the inspection, Kalmarhem will charge you 300 SEK. All keys, tags, laundry marker, and any parking cards belonging to the apartment must be handed over to Kalmarhem's Bobutik on the day the new agreement takes effect. In the case of a new rental agreement within Kalmarhem, points will be zeroed, and a new rental agreement will be sent by e-mail for digital signing.
